The NIFTY50 index after opening with a more than 100 points gap up at 17208 edged higher to mark a day's high at 17410 and thereafter was also pushed lower to settle on a flat note at 17339 level. In the sessions ahead, we see 17400 acting as a major hurdle and zones around 17260-17100 should possibly provide a crucial support.
