

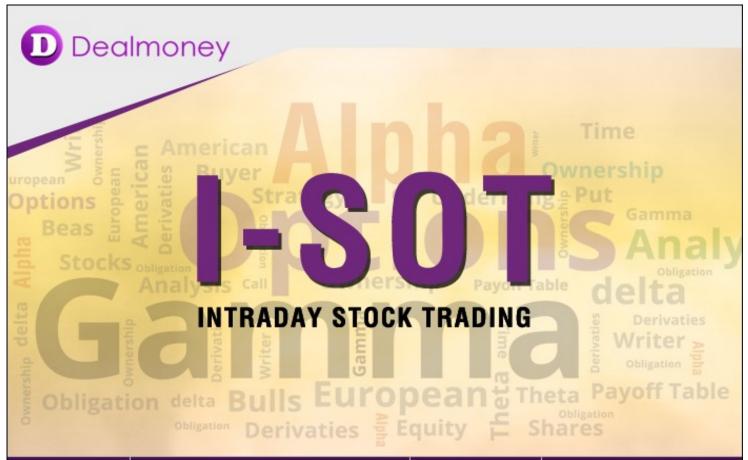

- Syngene International: It has extended its long-standing multi-discipline research collaboration with Amgen Inc, one of the world's leading biotechnology companies. The contract is currently extended until the end of 2026 and its scope includes integrated drug discovery and development solutions in discovery chem istry and biology, peptide chemistry, antibody and protein reagents, pharmacokinetics and drug metabolism and pharmaceutical development.
- Subros: It has bagged an order from Indian Railways for supply of Coach Air-conditioners (LHB-RMPU Ty 1) in a recently concluded tender. The company is already a supplier of Rail Driver Cabin Air-Conditioni system and with this business, the complete scope of air conditioning for rail driver cabin and coaches complete
- Ashok Leyland: Switch Mobility, a unit of Ashok Leyland, has planned to set up a manufacturing and tech nology centre in Spain with plans to invest 100 million Euros (about Rs 860 crore) over the next ten years With already a significant presence in the UK and India, the new facility will extend Switch's footprint as part of the company's global plans.
- Indiabulls Real Estate: It has raised Rs 75 crore through Secured Redeemable Non-Convertible Debentures (NCDs) on Private Placement basis. The date of maturity of the said Non-Convertible Debentures will be December 15, 2022 and coupon rate is 10.50% p.a.
- Hindustan Aeronautics (HAL): It has signed a contract with Bharat Electronics (BEL) for development and supply of 20 types systems for the LCA Tejas Mk1A programme. The five-year contract spanning from 202 to 2028 is valued at Rs 2,400 crore and involves supplying critical avionics Line Replaceable Units (LRUs), flight control computers and night flying LRUs.

Economic Snapshot

- Ratings agency ICRA in its latest report has revised downwards growth forecast for the domestic passenger vehicles industry to 8-11 percent in the ongoing fiscal (FY22) from the earlier estimate of 14-17 percent on account of the ongoing semiconductor shortage.
- In order to ensure robustness in working of banking entities, the Reserve Bank of India (RBI) has proposed to replace . existing approaches for measuring minimum operational risk capital requirements of banks with a new Basel-III standardised approach. 'Operational risk' refers to the risk of loss resulting from inadequate or failed internal processes, people and systems or from external events.




