

The stock has registered a range breakout on daily scales and hence we recommend a BUY above 550 for the targets at 582 maintainning a stoploss at 542.





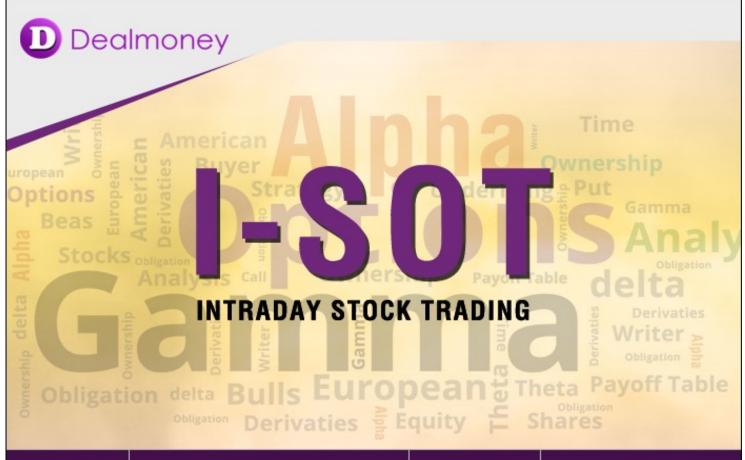

Economic Snapshot

- Amid concerns over the Omicron variant of COVID-19, rating agency ICRA in its latest report has said that India's real gross domestic product (GDP) is likely to maintain a 9% growth rate in fiscal 2022 and 2023. The Indian economy grew at 8.4% in the second quarter of the current fiscal, as against a growth of 20.1% in the April-June quarter.
- The finance ministry in its latest public debt management report has said that the government's total liabilities (including liabilities under the 'Public Account') stood at Rs 125.71 lakh crore in the September quarter (Q2FY22), up 3.97 per cent from the previous quarter. The total liabilities of the government were Rs 120.91 lakh crore in the three months ended June (Q1FY22).


