
NIFTY TO TRADE BETWEEN 17350-17700



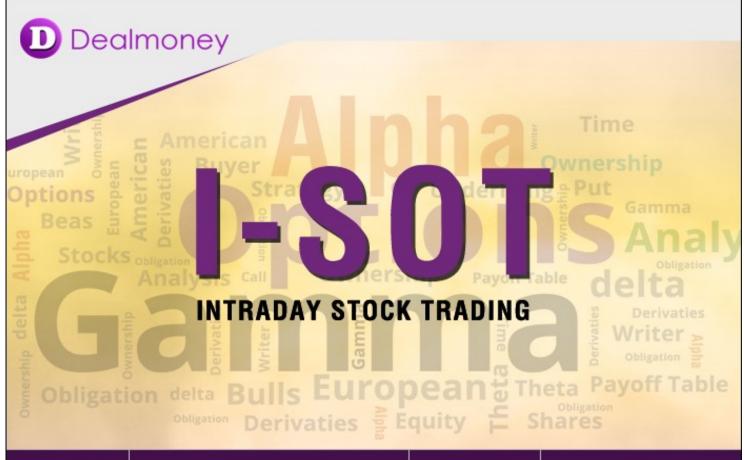

Economic Snapshot

- The Controller General of Accounts (CGA) in its latest data has showed that the central government's fiscal deficit at the end of November worked out to be 46.2 per cent of the annual budget target for the FY21-22 due to an improvement in the revenue collection. The deficit figures in the current financial year till November appear much better than the previous financial year when it had soared to 135.1 per cent of the estimates mainly on account of a jump in expenditure to deal with the Covid-19 pandemic.
- Indian manufacturing activity fell in the month of December, but stayed above the 50 mark that separates growth from contraction. As per the survey report, the Nikkei India Manufacturing Purchasing Managers' Index (PMI) - a composite single-figure indicator of manufacturing performance - eased to 55.5 in December from November's ten-month high of 57.6.


