
### NIFTY TO TRADE BETWEEN 18,000 -18,150








### Technical call of the Day GODREJCP FUT Sell below Rs 963.



- Domestic rating agency Brickwork Ratings in its latest report has revised its growth estimate for India's gross domestic
  product (GDP) to 10-10.5 per cent in the current financial year (FY22) from an earlier expectation of a 9 per cent growth. It
  said many economic growth indicators are suggesting a faster-than-expected revival in economic activities.
- Icra Ratings in its latest report has said housing finance companies (HFCs) may witness a growth of 8-10 per cent in current financial year (FY22) helped by rise in economic and higher demand. It mentioned in the first quarter of the current fiscal, HFCs registered nil sequential growth in the on-book portfolio as the second wave of COVID-19 impacted their disbursements and collection efficiency (CE).






