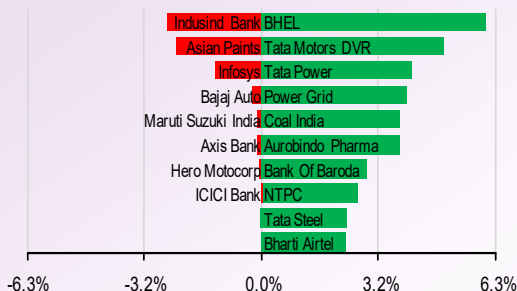
NIFTY TO TRADE BETWEEN 17,450 -17,700

Economic Snapshot

- Credit ratings agency ICRA in its latest report has said that domestic two-wheeler (2W) volume is expected to contract by 1-4 percent year-on-year this fiscal (FY22), as the relentless increase in 2W prices during the year and record-high petrol rates have kept consumers away from dealerships. Further, it said that the lacklustre festive season performance also highlights the continued wariness among the low-income population regarding big-ticket purchases.
- The RBI's Executive Director Mridul Sagar has said that the Monetary Policy Committee (MPC) should not continue with unconventional measures now, and it is possible to have lower liquidity levels while continuing with the growth-enhancing accommodative stance. He said as the growth normalises, it makes policy sense to lower the liquidity levels to some extent, and added that the negative real interest rates are impacting the retired people.

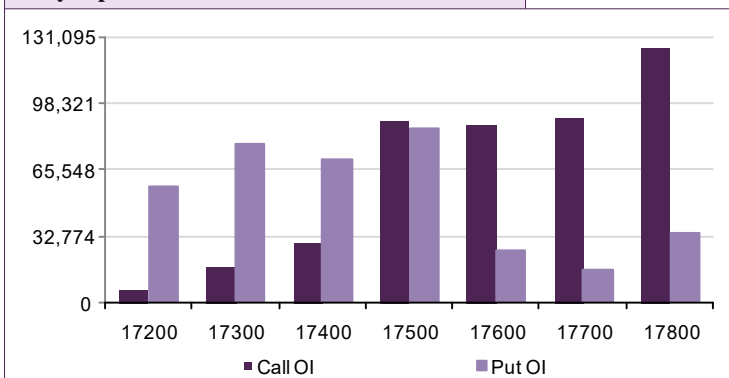

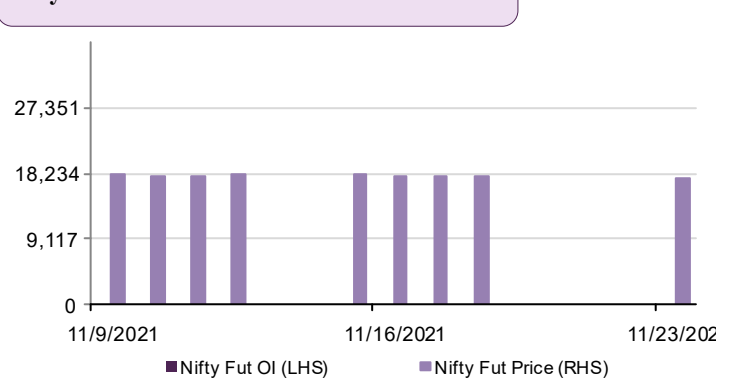
