
Buy above Rs 3580.









### Technical call of the Day APOLLOTYRE FUT Sell below Rs 211



- Investments in Indian capital markets through participatory notes (P-notes) rose to Rs 1.02 lakh crore till October-end, making it the highest level in 43 months. P-notes are issued by registered foreign portfolio investors (FPIs) to overseas investors who wish to be a part of the Indian stock market without registering themselves directly. However, they need to go through a due diligence process.






