
NIFTY TO TRADE BETWEEN 12,900-13,150.

Nifty traded in negative zone for most part of trading session; bulls ensure a smart recovery in last hour of session but failed to breach the resistance of 13,150 levels. We expect index to remain in range of 12,900-13,150 levels until there is breakout on either side.

Having traded in the red through most of the session, Indian benchmark equity indices trimmed losses to end flat on Wednesday, with the Nifty closing above 13,100. Nifty ended higher by 4.80 points or 0.04% at 13,113.8 level and Sensex ended lower by 37.40 points or -0.08% at 44,618.04




Chart of the Day KOTAKBANK FUT Sell below Rs 1813.



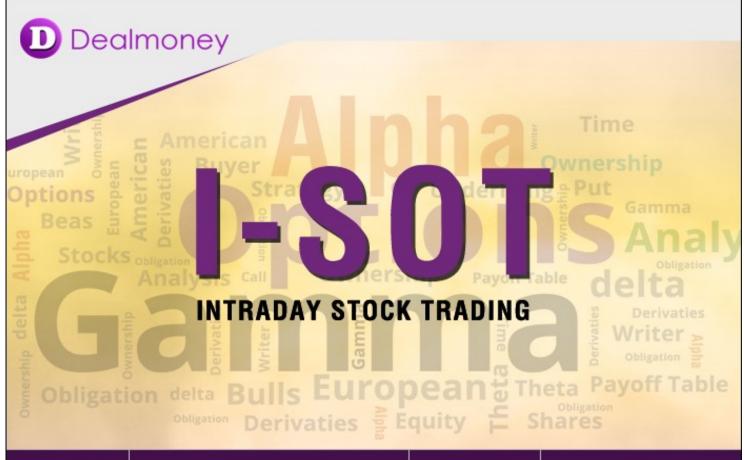

Economic Snapshot

- Passenger vehicle sales continued its growth momentum for the fourth straight month in November, spurred by festival demand even as market leader Maruti Suzuki India Ltd saw a decline. Wholesales or factory dispatches, reported by eight leading carmakers including Maruti Suzuki, Hyundai Motor India Ltd and Tata Motors Ltd showed industry sales grew 11% last month to 268,111 vehicles from 240,785 vehicles a year earlier.
- China has started importing Indian rice after a gap of two years and placed orders for shipment of about 5,000 tonnes of non-basmati rice due to competitive prices offered by India compared to other nations, according to the All India Rice Exporters Association (AIREA). India is the world's major exporter of rice, while China is the biggest importer. In 2006, China was given market access for Indian rice but shipments took place only during the 2017-18 fiscal. China buying rice from India comes at a time of heightened border tensions between the two nations.




