


NIFTY TO TRADE BETWEEN 11,740-11,950.


TRADERS COMMENT





- Godrej Properties: The company has reported 88.68% fall in its net profit of Rs 10.92 crore for the quarter under CMP: review as against net profit of Rs 96.44 crore for the same quarter in the previous year. Total income of the company decreased 58.46% at Rs 228.75 crore for Q2FY21 as compared Rs 550.62 crore for the corresponding quarter previous lmpact wear.
- Dabur India: The company has reported 20.62% rise in its net profit of Rs 392.68 crore for the quarter under review as against net profit of Rs 325.54 crore for the same quarter in the previous year. Total income of the company increased 16.99% at Rs 1974.13 crore for Q2FY21 as compared Rs 1687.32 crore for the corresponding quarter previous year.
- Sun Pharmaceutical Industries: The company reported a massive 70.4 percent year-on-year growth in consolidated profit driven by operating performance and tax credit, though forex loss limited growth. Consolidated profit increased to Rs 1,813 crore in quarter ended September 2020, compared to Rs 1,064 crore in same period last year.
- Adani Gas Ltd: The company reported a record net profit in the September quarter as sales returned back to pre-Covid levels quicker than anticipated, with the economy reinflating on easing of lockdown restrictions. Net profit in July-September quarter at Rs 136 crore was 13 percent higher than Rs 120 crore profit a year ago.

Economic Snapshot

- After recording positive growth in September, India's exports declined 5.4 percent to \$24.82 billion in October on account of dip in shipments of petroleum products, gems and jewellery, leather, and engineering goods. Trade deficit in October narrowed to \$8.78 billion as against \$11.76 billion, as imports also fell 11.56 percent to \$33.6 billion during the month under review. "India's merchandise exports in October 2020 were \$24.82 billion, as compared to \$26.23 billion in October 2019, showing a fall of 5.4 percent," the Commerce and Industry Ministry said in a statement. Major export commodities which recorded negative growth during October included petroleum products(53.30 percent), cashew (21.57 percent), gems and jewellery (21.27 percent), leather (16.69 percent), man-made yarn/fabrics/made-ups (12.82 percent), electronic goods(9.40 percent), coffee(9.25 percent), marine products(8.09 percent) and engineering goods (3.84 percent). Sectors which showed positive growth included rice, oil meals, iron ore, oil seeds, carpet, pharmaceuticals, spices, cotton and chemicals.
- The Reserve Bank of India is looking at diversifying its foreign exchange reserve investments amid the fall in global interest rates caused by the COVID-19 pandemic, according to two government sources aware of the development. The RBI's foreign exchange reserves stand at a record \$560.63 billion. The central bank, which mostly invests in gold, sovereign debt and other risk-free deposits, has seen returns fall as monetary policy loosened globally. US two-year government bonds ended at 0.16 percent on November 2.
