


NIFTY TO TRADE BETWEEN 10,960-11,180.

Technical call of the Day AUROPHARMA Buy above Rs 599.


We recommend a buy in the stock only above Rs599 with the stoploss of Rs587 for the target of Rs625.



Economic Snapshot

- Private equity (PE) funds are planning to earmark as much as \$100 billion to invest in Indian companies, according to a report in the Business Standard, as the latter struggle to deleverage and infuse fresh equity into their business and some may want to avoid being headed to the bankruptcy court. The BS report says that PE fund managers believe that the situation offers immense opportunities, not just to invest in small companies but also large conglomerates. Indian companies have struggled to raise capital over the past few years, thanks to their high debt, a lot of which has turned bad. As the economy slowed, capital further dried up as NPA-saddled banks looked to recover existing loans instead of extending fresh ones.
- Seeking to calm the nerves of startups worried over angel tax, the government has assured that explanation given by them to a tax notice in a limited scrutiny case would be summarily accepted without any questions asked by the taxman. This is part of the procedure being laid out by the Central Board of Direct Taxes (CBDT) to deal with pending angel tax assessments of startups, a move aimed at easing tax compliance for such ventures. For cases that land in limited scrutiny, "no verification of such issues will be done by the assessing officers during the proceedings and the contention of such recognised start-up companies the issue will be summarily accepted," the CBDT said in a circular, dated August 7.




