### **Economic Snapshot**


- Foreign investors pulled out close to \$6 billion from the capital market in November as anxiety gripped players over the impact of demonetisation amid mounting global concerns. Net withdrawal by FPIs from equities stood at Rs 18,244 crores last month while the same from the debt market was Rs 21,152 crores during the period under review, translating into total outflow of Rs 39,396 crores (\$5.78 billion). The foreign portfolio investor (FPI) outflows come following withdrawal of more than Rs 10,306 crores on net basis from the capital market (equity and debt) last month. Prior to that, equity segment had witnessed inflows of over Rs 20,000 crores.
- The balance amount in Pradhan Mantri Jan Dhan Yojna (PMJDY) account, which witnessed a growth of around 60 % in just 14 days after November 9, registered only 2.04 % growth after November 23.The balance in PMJDY accounts, which was at Rs 72,834.72 crores as on November 23, increased to Rs 74,321.55 crores as on November 30. Balance in these accounts increased by Rs 1,486.83 crores from November 24-30. The total number of PMJDY accounts increased by 10.83 lakh in the third week of demonetisation. The total number of PMJDY accounts increased from 25.67 crores as on November 23 to 25.78 crores as on November 30. However, around 16.47 lakh new accounts were added from November 9-23.


