
NIFTY TO TRADE BETWEEN 9190-9340

Sensex was up 64.02 points or 0.21% at 29974.24 and Nifty was up 27.30 points or 0.30% at 9265.15.



Chart of the Day Abirlanuvo Ltd Buy above Rs1550



Economic Snapshot


- India's trade deficit with China was recorded at \$ 46.7 billion during the April-February period of the last fiscal. Overall trade with China during the 11-month period decreased marginally by 0.87% to \$ 64.57 billion. During this period, India's exports to China grew by 8.69 per cent to \$ 8.94 billion while imports from the neighbouring nation declined by 2.26 per cent to \$ 55.63 billion, resulting in a shrinkage of 4.1 per cent in India's trade deficit with China.
- India will allow imports of 500,000 tonnes of duty-free raw sugar, a government official said, as a drought has cut output below consumption levels for the first time in seven years. Duty-free imports would be allowed until June 12. India levies a 40 percent import tax on sugar. India's sugar output in the 2016/17 season that began on Oct. 1 is likely to fall to 20.3 million tonnes, down from 25.1 million tonnes a year earlier.


