
NIFTY TO TRADE BETWEEN 8000-8200

Sensex was up 43.66 points or 0.17% at 26392.76, while NIFTY was up 14.40 points or 0.18% at 8143.15.



SCL managed to close above its 20


KSCL managed to close above its 20DMA with a rise in volume. We recommend a buy above Rs422 with the stop loss of Rs409 for the target of Rs440.


- In order to promote digital transactions across the country, government has asked banks to install one million additional points of sale (PoSes) within four months. To this end, banks have already placed orders for 600,000 PoS machines and another 400,000 are likely to be ordered in the next few days. There are about 1.5 million PoS terminals currently across merchants to facilitate card-based payments.
- The Reserve Bank of India (RBI) has removed the so-called two-factor authentication for online card transactions involving sums up to Rs2,000, in a move aimed at simplifying and encouraging electronic payments. The move will likely help cab aggregators, online movie ticket sellers and even e-commerce marketplaces. Currently, any online transaction involving a card requires users to first enter card details on the merchant's payment gateway, wait for a one-time password (OTP) to be sent to their mobile phone, and then use this number to complete the purchase. To be sure, discarding two-factor authentication for purchases up to Rs2,000 is an opt-in service, which means that customers will have to specifically opt for it.
