


#### **NIFTY TO TRADE BETWEEN 8400-8650**


Coal India is in uptrend and above its 20DMA. We recommend a buy above Rs335 with the stop loss of Rs325 for the target of Rs349.

#### **Economic Snapshot**


- Highway construction rises to 20.4 km/day. After three months of lull due to monsoon rains, the pace of highway construction has
  gathered momentum in October. Compared to 362 km, 367 km and 315 km respectively in July, August and September, construction of these roads in October stood at 612 km or 20.4 km/day. The pace, however, is still way lower than what is required to meet
  the construction target of 41 km/day set by the ministry of road transport and highways (MoRTH) for the current financial year.
- The war of words between Tata Group's patriarch Ratan Tata and his former protégé Cyrus Mistry escalated yesterday. Tata Group accused Mistry of "ulterior objective", and of employing "devious" methods to take over Indian Hotels Company Limited (IHCL) and other operating companies, with help from the independent directors. In another development, independent directors of Tata Chemicals came out in support of Mistry at the board meeting on Thursday. Earlier this month, independent directors of IHCL, too, had informed shareholders of their support for Mistry.


