

TRADERS COMMENT



TOP 5 SECTOR MOVERS





In the passenger vehicles category, global sales stood at 64,202 units last month as against 59,287 units during the same period in 2015, up 8 per- cent. 
Economic Snapshot

- India's fuel demand rose 4.3 percent in December compared with the same month last year. Consumption of fuel, a proxy for oil demand, totalled 16.53 million tonnes, data from the Petroleum Planning and Analysis Cell (PPAC) of the oil ministry showed. Sales of gasoline, or petrol, were 7.7 percent higher from a year earlier at 1.96 million tonnes. Cooking gas or liquefied petroleum gas (LPG) sales increased 7.9 percent to 1.94 million tonnes, while naphtha sales surged 5.5 percent to 1.08 million tonnes. Sales of bitumen, used for making roads, were 2.1 percent lower, while fuel oil use edged up 14.0 percent in December.
- Monthly automobile sales growth rate in India slipped to a 16-year-low in December with total vehicle sales declining by 18.66 percent
 as demonetisation hits the industry hard. According to latest SIAM data, most of the major segments, including scooters, motorcycles
 and cars, witnessed record decline December sales as the automobile sector continued to bear the brunt of negative consumer sentiments in the wake of the ban of Rs 500 and Rs 1,000 banknotes announced in November.
