
NIFTY TO TRADE BETWEEN 8290-8460



Chart of the Day IDFC Ltd Buy above Rs 57.50


IDFC is trading strong above 20 DMA support level. We recommend a buy only above Rs57.50 with the stoploss of Rs55 for the target of Rs61.




