

#### TRADERS COMMENT

Market ended a shade lower today after giving up early gains on widespread fag-end selling amid sustained capital outflows by foreign funds and a weak trend in European shares. Sentiment remained upbeat for the major part of the session after lower inflation data raised hopes of a rate cut by RBI next month, but the index turned lower towards the fag-end as profit-booking emerged. Sensex was down 5.94 points or 0.02 % at 26,298.69 while Nifty was up 3.15 points, or 0.04 % at 8,111.60




#### **Economic Snapshot**

- Driven by strong and stable fundamentals, Nasscom has reiterated that the long term opportunity and potential for the industry remains unchanged with a vision to achieve \$350 billion by 2025.As part of its mid-year performance review of the IT-BPM industry, the Nasscom also shared its revised guidance stating that the industry is expected to grow at 8-10 % (in constant currency) during this financial year. In October, it had said it expects the \$143-billion IT sector to grow at 10-12 %
- Iron ore production in the country has increased by nearly 26 % in the six-month period between April and September this year to 84 million tonne, from 66.5 million tonnes in the same period the previous year. there has also been a significant decrease in iron ore imports. In the first five months of this fiscal (April to August), iron ore import was at 1.59 million tonnes, significantly lower than in the same period last year.


