


Economic Snapshot

- To make the GST regime less onerous, the Centre and states have decided to water down the penal provisions to ensure a trader gets immediate bail if the alleged tax evasion is up to Rs 2 crore. The GST Council, at its last meeting, has decided that the provision of arrest will be restricted to forgery and non-deposit of collected taxes with the exchequer within the stipulated timeframe.
- In the eight weeks since demonetisation, banks have lent just over Rs 60,000 crore which is way below Rs 2,66,900 crore banks disbursed in the same period last financial year (FY16). According to Reserve Bank of India data, the outstanding loans of the banking systems stood at Rs 73,53,280 crore at end of November 11, 2016. It rose to Rs 74,13,415 crore by January 6, 2017.


