
NIFTY TO TRADE BETWEEN 8980-9180



Chart of the Day Castrol Ltd Buy above Rs427.50




- Domestic air passenger traffic surged by nearly 16 per cent to 86.55 lakh in February over the same period last year as compared to 74.76 lakh fliers in the same month of 2016, according to the DGCA. Significantly, in January, air passenger traffic had surged 25.13 per cent to 95.79 lakh. According to data, budget carrier IndiGo ferried the highest number of passengers in February at 34.19 lakh. Its load factor in February stood at 93.7 per cent in the reporting month. SpiceJet delivered the highest ontime performance from four metro airports at 81.1 per cent in February 2017.
- The Union government has set a target of bringing more than 76 lakh hectares under irrigation by 2019. The government has ensured availability of urea and other fertilisers at lesser rates without any hurdle. The government has also decided to produce neem coated urea for the benefit of farmers.. This urea is required less in quantity and gives higher crop yield by minimising the investment cost. The government has made a provision of Rs 8,000 crore for the promotion of dairy, poultry, fisheries and allied sector in 2017-18


