




Economic Snapshot

- SBI slashed bulk deposit rates by up to 1.9 % taking advantage of the surge in deposits following demonetisation.SBI has reduced interest rates on bulk deposits ranging between Rs 1-10 crores..With the revised interest rates, the 180-210 day fixed deposit will attract 1.90 % lower interest rate at 3.85 % as against the 5.75 % earlier. For fixed deposits between 1 year to 455 days, the rate has been lowered to 6 % from 4.25 %.For FDs between 7 days to 45 days, the new rate will be 1.25 % lower at 3.75 %. Earlier this month, SBI had cut fixed deposit rates for less than Rs 1 crores on select maturities by up to 0.15 %
- India's The Jan Dhan bank accounts, which were opened for the poor, have seen huge deposits to the tune of Rs 21,000 crores in the fortnight since demonetisation. One of Prime Minister Narendra Modi's key financial reforms is likely being misused to get around another key policy. Trinamool Congress-ruled West Bengal leads in this sudden spurt in deposits, followed by Congress-ruled Karnataka. If the current trend continues, total deposits into these accounts may swell beyond the Rs 65,000 crores that was collected from the recently concluded income disclosure scheme, given that there are five more weeks to go before restrictions on currency deposits come into play.


