
NIFTY TO TRADE BETWEEN 7875-8120



Corporate Snapshot

- ONGC will pay over USD 1.2 billion for buying debt-laden GSPC's entire 80 per cent stake in KG-basin natural CMP: 193.0 gas block, which is struggling to start commercial production despite trial outputs starting nearly two-and-half P/E(ttm): 16.6 years back. Besides the payout to GSPC, ONGC will have to pay for the entire development cost of the six discoveries which may run into at least a couple of billion dollars.
- Mahindra & Mahindra plans to increase prices of its vehicles by up to Rs 26,500 from January as it looks to partially offset rising input costs. Prices of passenger vehicles would go up in the range of Rs 3,000 to Rs 26,500 P/E(ttm): 20.9 depending upon the model.
- Balrampur Chini Mills, has got environment clearance for expansion of its Babhnan unit of distillery and cogeneration power in Uttar Pradesh, entailing Rs 72-crore investment. The company has proposed to increase the production capacity of its molasses-based distillery plant from 60 kilo litres per day to 100 kilo litres per day (KLD) | Neutral along with co-generation power from 1 MW to 6.76 MW in Gonda district.
- Welspun Enterprises Ltd (WEL) is looking to divest its entire 15.49 per cent stake in Welspun Energy. The board of directors of the company, subject to the approval of the members of the company, has approved sale of its entire investment of 60,493,342 equity shares representing 15.49 per cent in the paid up equity share capital Meutral of Welspun Energy.
- Camlin Fine Sciences (CFS) said it is acquiring 51 percent stake in China-based Ningbo Wanglong Flavors and Fragrances Company Ltd (NWFFCL). The acquisition is subject to RBI approval and expected to be completed on or before June 30 next year and cost of proposed acquisition will be disclosed after the completion.

Economic Snapshot


- Over India's gross value added growth is likely to be at 6.6 per cent in 2016-17 as economic activity will take more time to normalise following the government's move to demonetise high-value notes, rating agency ICRA has said. Although currency liquidity is likely to improve significantly by the end of January 2017, economic activity may take longer to normalise.
- In a bid to calm stock market players, Finance Minister Arun Jaitley on Sunday clarified that there was no intention to impose tax on long-term capital gains from trading in shares, and went on to blame "some sections" of the media for "misinterpreting" Prime Minister Narendra Modi's speech on Saturday.
- The Pension Fund Regulatory and Development Authority (PFRDA) is exploring alternative mechanisms for introducing different variants of withdrawal options. This could include systematic/phased withdrawal options, under which different combinations of withdrawal packages with/without annuity options can be offered to subscribers.


