
NIFTY TO TRADE BETWEEN 7820-8060

Benchmark indices settled the day lower as capital gains tax woes spooked the markets after PM Narendra Modi on Saturday said that people in financial markets must make a "fair contribution" to nation building, comments that were seen as setting up the prospect of higher taxes for investors. Sensex was down 233.60 points or 0.90% at 25807.10, while NIFTY was down 77.50 points or 0.97% at 7908.25.



• **Jet Airways** announced the deployment of higher seating capacity aircraft on two domestic and an equal number of international routes from early next year amid growing passenger demand. Jet Airways flights to Kuwait P/E(ttm): 3.6 and Jeddah from Mumbai and vice versa as well as to Chennai and Bangalore from here would be operated by the 254-seater Airbus A330 aircraft from January, 2017 in place of the existing Boeing 737.

- NTPC's wholly-owned arm NTPC Vidyut Vyapar Nigam has signed power purchase pact with Nepal Electricity CMP: Authority to supply 160 MW power for January-May 2017. NVVN is the only government company in the power P/E(ttm): sector engaged in the business of power trading.
- Larsen & Toubro (L&T) construction arm has bagged orders worth Rs 3,039 crore across various business segments, including power transmission and distribution, and heavy civil infrastructure. In the water and effluent P/E(ttm): treatment sector, the company won orders worth Rs 1,422 crore. In power transmission and distribution business, the company secured major orders worth Rs 1,036 crore for electrification works. In heavy civil infrastructure business, the company bagged an order worth Rs 359 crore from Inland Waterways Authority of India (IWAI).
- **Lupin** has received tentative approval from the US health regulator to sell Olmesartan medoximil tablets, used for treating high blood pressure, in the American market. It has received final approval for Olmesartan medoximil P/E(ttm): 18.5 tablets, 5 mg, 20 mg and 40 mg from the US Food and Drug Administration (USFDA). Impact Neutral


- The government is likely to come up with an ordinance to penalise anyone caught in possession of old Rs 1,000 and Rs 500 notes worth more than Rs 10,000 after December 30, the last date to deposit demonetised currency notes in banks. Sources said the ordinance is likely to be finalised before December 30. They added that the government is working out the penalty on the same which could go up to Rs 50,000 or more.
- In India Inc raised USD 488.49 million via External Commercial Borrowings (ECBs) and Rupee Denominated Bonds (RDBs) in November 2016, as per RBI data. The Indian companies had raised USD 3.16 billion from foreign sources in the same month a year ago. However, the data is not comparable as borrowings through RDBs were included only this year. The number of companies raising money through ECB route in November 2016 fell to 34 from as high as 53 in November 2015.


