

### **Economic Snapshot**

6 years

The National Highways Authority of India (NHAI) awarded fewer contracts in the first six months of the current financial year, compared to the same period last year. Not only was the number of projects less this year, the total length (km) of these projects was also down 16 %. Thirty-six highway ontracts, totalling a length of 2,549 km, had been awarded in the April-September period of 2015-16. According to NHAI data, 29 projects of 2,130 km, estimated at Rs 26,000 crores, were awarded in the first half of FY17. Half of the total contracts awarded this year were on hybrid annuity model, where the government would bear 40 % of the total highway cod.


 Banks' investments in mutual fund (MF) instruments jumped the most in over seven years in the fortnight ended October 14. With an increase of Rs 71,500 crores during the fortnight, banks' total investment in MF instruments also hit an over five-year high of Rs 86,423 crores. The rise in banks' investment in MF instruments is most likely due to fresh investments by public sector banks (PSBs) that are grappling with stressed loan books and low credit demand from the industry
