
## **NIFTY TO TRADE BETWEEN 8640-8800**

The Sensex and Nifty closed at their lowest in nearly a month on Tuesday as a slump in European shares offset earlier gains after investors awarded the first US presidential debate to Democrat Hillary Clinton over Republican Donald Trump. Sensex was down 70.58 points or 0.25% at 28223.70, while NIFTY was down 16.65 points or 0.19% at 8706.40.





## **Economic Snapshot**


- India will invest up to \$2 billion in Sri Lanka over the next four years in a range of sectors including real estate, energy and infrastructure. India is Sri Lanka's largest trading partner and the South Asian neighbours are considering a broader trade agreement as President Maithripala Sirisena's government tilts towards New Delhi after his predecessor pursued a pro-China policy
- The Jan-Dhan Yojana is poised for a huge leap by extension of its banking platform to phones not connected to the internet. It is the next big thing on the government's financial inclusion programme. The option is to make banking services via the unstructured supplementary service data (USSD) technology that had become technically possible in India some time ago.


