
NIFTY TO TRADE BETWEEN 8780-9020



Chart of the Day Crompton Greaves Ltd Buy above Rs69.50




- The states' fiscal deficit will rise only marginally to 3.3 per cent in financial year 2017-18 (FY18) from the expected 3.2 per cent in 2016-17 (FY17), domestic ratings agency India Ratings and Research (Ind-Ra) said. The aggregate states' GDP-to-debt ratio will also go up marginally to 24.3 per cent in FY18 from 24 per cent in FY17, it said. Market borrowings of the states will increase to Rs 3,70,000 crore from the Rs 3,50,000 crore in the ongoing financial year, it said.
- The Central Statistics Office (CSO) is due to unveil today the revised advance estimate for gross domestic product (GDP) growth for the financial year (FY) 2016-17 after factoring in the note ban impact in the December quarter. In the wake of the cash ban, a number of think-tanks and experts have lowered their projections for 2016-17 to even below 7.1 per cent which was put out by the CSO in its advance estimates on January 6. Earlier this month, the Reserve Bank of India (RBI) had lowered GDP growth forecast for this FY to 6.9 per cent, but at the same time projected a rebound in the next fiscal at 7.4 per cent.


