

NIFTY TO TRADE BETWEEN 8980-9145



Technical call of the Day TataComm Ltd Future Sell below Rs715


We recommend a Sell in TataComm Future only below Rs715 with the stop loss of Rs730 for the target of Rs691.






Economic Snapshot

- Finance Minister introduced in Lok Sabha four bills on Goods and Services Tax, providing for a maximum GST rate of 40 per cent, an anti- profiteering authority and arrests for evading taxes.CGST provides for a maximum tax of 20 per cent. Actual rates would how-ever be a four-tier tax structure of 5, 12, 18 and 28 per cent as approved by the GST Council. The peak rate of 40 per cent is only an enabling provision for financial emergencies. To protect small businesses, the CGST provides for a tax of no more than 1 per cent of turnover for manufacturers with annual turnover of up to Rs 50 lakh. A 2.5 per cent tax is prescribed for suppliers.
- A total 6,604 km of highways has been constructed during the April-February period against the target of 15,000 km for the full fiscal, Parliament was informed. Ministry has allocated funds of Rs 1 lakh crore which includes internal and extra budgetary resources/ borrowings of Rs 59,279 crore for the development of national highways during the current financial year. In a reply to a separate query, the Minister said the Ministry has fixed a target of building 41 km of roads a day and 20 km a day was achieved as on February 28 as against 16 km a day in 2015-16.


