
NIFTY TO TRADE BETWEEN 7980-8200

The December futures and options series kicked off on a firm note on Friday, as the BSE Sensex and NSE Nifty50 surged nearly 2 % on brisk buying by funds and retail investors at lower levels amid firm Asian cues. The 30-share Sensex closed 456.17 points, or 1.76 %, higher at 26,316, while the 50-share Nifty50 pack ended 1.87 % higher at 8,114.



It reported a 35% rise in revenue to Rs.1,400 crores during the same period. This is the seventh consecutive profitable quarter for SpiceJet after it recovered from a near shut down in December, 2014.

• Tata Steel's board has elected independent director O. P. Bhatt as its Chairman, replacing ousted Chairman Cyrus P. Mistry, even as the company has convened an EGM on December 21 to remove Cyrus P. Mistry and Nusli N. Wadia as directors. Also the Competition Commission has approved the proposed acquisition of urea and customised fertilisers business of Tata Chemicals by Norway's Yara Fertilisers. Under the deal, Tata Chemicals will sell its urea plant in Babrala, Uttar Pradesh, which has an annual capacity of about 1.2 million tonnes for an estimated Rs 2,670 crores.

Economic Snapshot


- Centre reduces equity support for Air India by half to Rs 1,713 crores. Against the demand of Rs 3,900 crores, the state-owned airline will get only Rs 1,713 crores in FY17. The capital infusion is part of the Rs 30,000-crores bailout package for Air India in the form of equity support by the government. So far, Rs 23,933 crores has been released to the company in several tranches. Air India sources said that the government did not meet its full demand for the current fiscal citing its own constraints regarding meeting the fiscal deficit. Due to the reduced support during the fiscal, the airline may find it difficult to meet its operational and financial targets.
- The Centre has set a modest 14 % target for revenue growth under the Goods and Services Tax and prescribed a formula that it will use to compensate States for any revenue loss under the GST for five years. Also the draft GST (Goods and Services Tax) law has suggested the levy of a compensation cess, which will be credited to the GST Compensation Fund. After five years, the unutilised cess would be transferred to the Consolidated Fund of India and then devolve to States based on the formula of the Fourteenth Finance Commission.


