

Economic Snapshot


- The operating losses of Air India have been steadily coming down over the past few years and the same have converted into operating profits, Civil Aviation Minister has reported. As per provisional figures for 2016-17, the airline is projected to see an operating profit of Rs 300 crore and net loss after tax of Rs 3,643 crore. Last fiscal, Air India had an operating profit of Rs 105 crore and a net loss after tax of Rs 3,836.77 crore. The government's Turnaround Plan (TAP) or Financial Restructuring Plan (FRP) provides for equity infusion worth Rs 30,231 crore in the airline up to 2021 subject to achieving certain milestones.
- The government will borrow Rs 3.72 lakh crore from the market in the first six months of the next fiscal beginning April. The borrowing represents 64% of the full-year borrowing target. The April-September borrowing is slightly more than previous year because the finance ministry and the Reserve Bank of India expect spending to pick up pace early. The government has budgeted a gross market borrowing of Rs 5.8 lakh crore and net borrowing at Rs 4.25 lakh crore for FY18. The fiscal deficit is pegged at 3.2% of GDP for the year.


