Indian shares posted their biggest declines since the Brexit vote in June, after India said it had conducted "surgical strikes" on suspected militants preparing to infiltrate from Pakistan-ruled Kashmir. Sensex was down 465.28 points or 1.64% at 27827.53, while NIFTY was down 153.90 points or 1.76% at 8591.25.





Chart of the Day Reliance Industries Ltd Buy above 1075



Economic Snapshot


- Indian companies have raised Rs 17,283 crores through initial public offerings in the first half of the current fiscal, making it the highest fund mobilisation in nine years, At present, 16 companies planning to raise Rs 5,745 crores already have Sebi's approval and another five firms intending to mop up Rs 6,810 crores are awaiting clearance from the regulator. This was the highest fund raising since first half of 2007-08, when companies had raked in Rs 21,244 crores through IPOs
- Unemployment rate in India has shot up to a five-year high of 5 per cent in 2015-16, with the figure significantly higher at 8.7 per cent for women as compared to 4.3 per cent for men. According to the fifth annual employment-unemployment survey at all-India level, about 77 per cent of the households were reported to be having no regular wage/salaried person.
- The Inland Waterways Authority of India (IWAI) has signed three separate memorandum of understanding (MoUs) with Dredging Corporation of India (DCI), Mormugao Port Trust (MPT) and Paradip Port Trust (PPT). As per the MoU between IWAI and MPT, there will be development of National Waterways like Mandovi, Zuari, Chapora, Mapusa and Sal rivers and Cumbharjua canal. The MoU between IWAI and PPT will result in collaboration between IWAI and PPT to develop a viable navigation system on NW-5 in Odisha for Phase-1


