


Economic Snapshot

- India's lower house of parliament passed key legislations, putting Asia's third-largest economy on course to launch a nationwide goods and services tax (GST) from July. The bill is expected to boost economic growth by about 0.5 percentage points in its first year of implementation. Proposed tax rates range from 5 to 28 percent, with 12 percent and 18 percent being the standard rates. It has not been decided yet which tax rates will apply to which categories of goods.
- A total of Rs 1.2 lakh crore was spent on development of national highways during the last three fiscals. A total of Rs 71,517 crore was spent by the private sector on national highways construction under PPP mode during the last three years, the minister said in a separate reply to the lower house.


