NIFTY TO TRADE BETWEEN 8180-8350



NIFTY was down 30.00 points or 0.36% at 8243.80.




Technical call of the Day HDFC Bank Ltd Buy above Rs1200

We recommend a buy in HDFC Bank only above Rs1200 with the stop loss of Rs1185 for the target of Rs1230.




Economic Snapshot

- Petrol pumps across the country will not accept credit and debit card payments for fuel sales from tomorrow after banks decided to put transaction (MDR) charge on them instead of consumers. To promote cash-less transactions, the government had waived the Merchant Discount Rate (MDR) on fuel purchase post demonetisation for consumers. But after the expiry of the 50-day window, the banks have decided to levy MDR on petrol pump owners.
- India's domestic IT spending is estimated to grow at 12.9 percent to Rs 2,14,012 crore this year, helped by government's push for digital services. Spending in the category grew at 12.3 per cent last year, against a prediction of 13.5 percent.
