
#### NIFTY TO TRADE BETWEEN 14,400-14,550.

#### TRADERS COMMENT

Indian equities stayed firm at record high levels during Monday's trading session a as strong kick-start to Q3 earnings, decision to roll out Covid-19 vaccine in the country as early as January 16, and hopes of a greater stimulus package in the US pushed the benchmark. Nifty ended higher by 137.50 points or 0.96% at 14,484.80 level and Sensex ended higher by 486.81 points or 1.00% at 49,269.32.







## **Economic Snapshot**

- Ratings agency ICRA in its latest report has said that the domestic demand for petroleum products is expected to increase at a healthy rate of 8 to 10 per cent in next financial year (FY22) on a year-on-year basis. The report said a growth in economy and pick-up in industrial activity. The report explained that growth in Motor Spirit (MS) consumption is expected due to preference for personal mobility while higher off-take of High Speed Diesel (HSD) and industrial fuel would likely be driven by a pick-up in economic activity. As per the report, Aviation Turbine Fuel (ATF) demand is expected to lag due to the discretionary nature and the perceived risk of air travel. Furthermore, the report pointed out capex and investments are expected to be healthy in FY22, as companies make up for the time lost due to restrictions and lockdowns in FY21. It said a clearer outlook on demand and prices, and a greater impetus for local manufacturing under 'Aatmanirbhar Bharat' are expected to spur demand over the long term.
- India's soybean meal (soybean khali) exports rose nearly three times to 2.68 lakh tonnes during December last year on higher demand in the global market, SOPA said on Monday. In December 2019, soybean meal exports stood at 90,000 tonnes, as per data released by Indore-based Soybean Processors Association of India (SOPA). France (43,257 tonnes) and Iran (41,500 tonnes) were among the biggest importers of Indian soybean meal in December, the data showed. The leftover product after extracting soybean oil is called soybean meal. India's soybean meal exports grew two-and-a-half times to 5.99 lakh tonnes during the first quarter of current oil marketing year (October 2020-September 2021).




